



## **OWFL Rules & Rule Modifications 2025 – U15**

NOTE: This document only highlights rules that are called differently for OWFL U15 play. Most fouls (Illegal Contact, Block, Offside, etc.) are not outlined in this document. For a list of Major, Minor, Restraining Line and Goal-Circle fouls, see the most up-to-date version of the World Lacrosse Women's Field Rules Book, 2025-2026 edition. Rule modifications contained in this document should be taken as the official OWFL rule when they conflict with a rule in the rule book.

## New for 2025

|                          | GAME DURATION & SET-UP   |
|--------------------------|--|
| Field & Lines            | 11m Fan + 15m MA lines. See the OWFL 2025 Field Lining Guide for more.   |
| Quarter Length           | 12.5 min.  |
| Mercy Rule               | Whenever a team leads by 12 or more goals, the losing team will be awarded the ball at centre following every goal. If the score differential becomes less than 12 goals, resume draws after goals. In either instance, play is restarted with a whistle. There are always draws to restart quarters, regardless of the goal differential. When the mercy rule is in effect, the clock runs in the last 30 seconds of Q1, Q2 and Q3 or 2 minutes of the game (Q4). |
| Timeouts                 | As per Rule Book. Possession timeouts are permitted outside either AFA.  |
| Stopped Time             | As per Rule Book. All whistles, last 30 seconds of Q1, Q2, Q3, and 2 min of Q4. When self-start is permitted, players may self-start during stop-time.   |
| Shot Clock               | No shot clock in use.  |
| Goggles                  | Goggles are mandatory for OWFL play. Violation = Minor Foul (Illegal Equipment). For more, see and any Adaptators .  |
|                          | GOALIES & THE GOAL-CIRCLE  |
| General                  | Rule 17 Goal-Circle Rules & Penalties applies as written in the Rule Book, i.e. defense may pick up a loose ball in the Goal-Circle and exit the Goal-Circle in possession of the ball and various other changes.  |
| GAME PLAY & FOULS        |  |
| Stick Checking           | Legal stick checking is permitted. Covering is now Withholding the Ball (Rule 19.A.8). Empty Stick Checks = NO FOUL. The only time it is illegal to check an opponent's empty stick is when that opponent is attempting to catch a pass in the air (Rule 19.A.9).  |
| Stick-to-Body<br>Contact | No horizontal stick-to-body contact is permitted at any time. The intent is to eliminate the middle of the shaft of a defender's stick from contacting the ball carrier's arm once or multiple times in a row. The defender's stick head should NOT be parallel to the butt-end of the stick or (as on the draw) within approximately 30° from being parallel with the ground. Violation = Major Foul.   |
